

# GENTRY FALL FESTIVAL BURN-OUT ENTRY FORM

## ENTRY RULES

1. Entry fee of \$10.00 per vehicle.
2. Vehicle operators must be 18 years of age or older and present a valid driver's license.
3. Motorcycles and ATVs are not permitted.
4. All entries must pass a safety inspection by a contest official before they will be allowed to compete.
5. Seatbelt usage is mandatory.
6. Signed Release of Liability (below).



## CONTEST SPECIFICS

1. Meet at Staging Area at 1pm
2. No one is allowed within 25' of the vehicle currently participating in the contest.
3. All vehicles entered must remain in the staging area until called for by a contest official.
4. Vehicles will be called from the staging area one at a time.
5. Operators are to approach the competition area in a slow and controlled manner.
6. The non-driving wheels will be chocked by a contest official.
7. A rope will be loosely tied to the operators arm and held by a contest official.
8. At any time if the contest official tugs the rope, the operator is to shut down the vehicle immediately.
9. The contest will begin when the contest official starts the clock and signals the operator.
10. Burnouts will be timed to 30 seconds.
11. Shifting through forward gears is allowed.
12. The contest official may signal the operator to stop early for any reason.
13. Harassment of a judge or official will result in immediate disqualification and forfeiture of the entry fee.
14. All decisions of the judges are final.
15. A contest official will notify the judges if a vehicle is in violation of any contest rules.

## RELEASE OF LIABILITY

1. HEREBY RELEASES the promoters, participants, associations, sanctioning organizations or any subdivision thereof, officials, sponsors, advertisers, owners, and lessees of premises FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS.
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees FROM ANY LOSS, LIABILITY, DAMAGE, OR COST related to the EVENT (S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK, BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT (S) whether caused by the NEGLIGENCE OF RELEASEES or otherwise.
